- Last three (3) years Financial Statements and Annual Reports including Balance Sheet, Profit and Loss and Cash Flow Statement (preferably audited);

- Tender must ensure that the proposed Contracting Entity/ies are operating and owning the proposed Vessel/s, holding a valid DOC (ISM Document of Compliance) released by an IACS Classification Society allowing the TENDERER (and its proposed Contracting Entity/ies) to operate the proposed vessel in compliance with the International Safety Management Code applicable;
- The DOC that has 5 years validity and must report the annual verification(s) by the Classification Society who released the Certificate.

EOI_AZE_B18_B31_12_ref_2025: (Provision for new Inspection Data Management System (IDMS) Software for Asset Integrity Team):

- Creation and maintenance of a detailed asset register: The software must be able to keep the asset register including the design, manufacturing and operational details of the equipment. The software must be able to keep various technical documents related to the equipment e.g. P&IDs, drawings, photographs;
- Inspection data management: The software must support automatic data entry for inspection results, including wall thickness readings and images;
- Automatic Corrosion Rate and Remaining Life Calculations: The software must automatically calculate corrosion rates based on inspection results, and
 it must automatically calculate the remaining life of assets using inspection data;
- Anomaly management: The software must support anomaly management workflow process i.e. anomaly review, approval etc;
- SAP Integration: The software must support data synchronization with SAP, our work management tool, for tracking inspection work order (WO) progress.d
