TECHNICAL REQUIREMENTS:

EOI_AZE_B15.06_B18_B31_19_2025 - Provision of an Integrated Light Well Intervention Services:

- The main Scope for this tenderer is to perform Well Intervention in Riserless Mode for Production Logging Test (PLT), Water Shut-Off (WSO) and Acid Stimulation;
- The objective is to isolate water bearing levels on 3 firm wells, and pump acid in bull heading to reduce impaired productivity on 1 firm well;
- Minimum requirements for Integrated Light Well Intervention Services (Personnel, Downhole Intervention Equipment, Well Re-Entry Package, Coiled Tubing & High-Pressure Pumping Equipment and supplies, Slickline/Wireline Package and IWOCS Systems) to be used for the planning and execution of Light Well Intervention.

EOI_AZE_B31 & B31/B21_23 2025: Provision of Geophysical and Geotechnical Survey:

- Experience: i) in deep water (from 300m to 1700m) of Geophysical and Geotechnical survey; ii) operating in "seabed" mode for "in situ" testing and sampling up to 20m depth below the seabed; iii) in "downhole drilling" mode and/or operation in seabed drilling mode for "in situ" testing and sampling through drill pipes; iv) in Acquisition, processing, interpretation and transmission of appropriate Geophysical and Geotechnical data;
- Work: a) Experience previously worked in Angola in Geophysical and Geotechnical Survey; ii) have a Local office in Angola;
- History of Geophysical and Geotechnical Surveys carried out worldwide and in "Offshore": Company will have to specify
 the water depth, the depth of the hole below the seabed and type of soil/rock samples related to the geotechnical surveys.

EOI_AZE_B18_B31_NGC_24_2025: Infield Transfer Vessels (ITVs):

- Tender must ensure that the proposed Contracting Entity/is are operating and owning the proposed Vessel/s, holding a valid DOC (ISM Document of Compliance) released by an IACS Classification Society allowing the TENDERER (and its proposed Contracting Entity/ies) to operate the proposed vessel in compliance with the International Safety Management Code applicable;
- The DOC that has 5 years validity and must report the annual verification(s) by the Classification Society who released the Certificate.
