Azule Energy and the Ministry of Health sign a Memorandum of Understanding to extend the project to strengthen cardiac surgery services throughout the country

Luanda, 8 October 2025 - Azule Energy and the Ministry of Health signed a Memorandum of Understanding (MoU) that marks the extension of Azule Energy's financing to the Cardeal Dom Alexandre do Nascimento Hospital Complex, for the start of the second phase of the Cardiology and Cardio-Surgery Services Reinforcement Project.

The overall investment, estimated at 18 million euros, will be implemented, in partnership with the Monzino Cardiology Center, located in Italy, over a period of three years (2025-2028) and aims to expand the hospital's technical and human capacity, improving the diagnosis and treatment of cardiovascular diseases.

In this new phase, the program will extend to the Benguela, Huíla and Huambo provinces, where a significant number of patients come from, according to the data in the project's first phase report. The objective is to decentralize access to specialized health care, bringing diagnosis, cardiac surgery and medical follow-up services closer to communities through the creation of the first National Network of Cardiac Surgery in Angola.

The MoU was signed between Azule Energy CEO, Adriano Mongini and the Minister of Health, Sílvia Lutuca. The event was also attended by representatives of the Ministry of Health, the Board of Directors of the Cardeal Dom Alexandre do Nascimento Hospital and Azule Energy, reinforcing the value of public-private partnerships in strengthening the national health system.

"For Azule Energy, this partnership is more than a social investment: it is a long-term commitment to Angola's human development. Just as we generate energy responsibly, we also want to generate social energy — the energy that saves lives, trains talents and inspires confidence", said Adriano Mongini.

About the Project



The first phase of the Project, ran from June 2022 to June 2025, and allowed the performance of 284 cardiac surgeries and the training of more than 1,100 health professionals, all of them Angolan staff.

This new phase also aims to create the first National Network of Cardiac Surgery in Angola, placing the Hospital Complex for Cardiopulmonary Diseases Cardeal Dom Alexandre do Nascimento (CHCDP) as a center of excellence.

Azule Energy is a 50/50 independent joint venture officially established on 1 August 2022, combining the bp and Eni Angolan businesses. The company is Angola's largest independent equity producer of oil and gas, holding net resources of 2 billion barrels of oil equivalent and growing equity production to about 250,000 barrels of oil equivalent a day (boe/d) over the next 4 years.
